

# **Privacy Statement**

#### Introduction

Thank you for visiting *cybertherapyconsulting.com* (the site), presented to you by Dr. Marie C. Dumas, EI.

Your privacy is important to me. As such, I provide this Privacy Statement explaining my online information practices and the choices you can make about the way your information is collected and used at this general audience site. The term "the services" refers to all operational activities conducted by Cybertherapy Consulting. Please note that legally mandated record keeping and reporting in the cities and countries of operation, and are permitted to retain necessary data for legitimate use purposes.

#### The Information I Collect

Throughout the site, you may be able to inquire about one of my services and to request appointments, give consents, or send forms. In the course of these various offerings, I seek to collect from you various forms of personally identifiable information that is required for the operation of the consulting practice.

Examples of the types of personally identifiable information that may be collected include: name, address, e-mail address, telephone number, emergency contacts, and information about your participation in my programs and services.

I maintain a client database inside my website, available only to myself as an administrator. This is to facilitate my communication with you.

My website is hosted on the Wix.com platform. Wix.com provides me with the online platform that allows me to publish my site and services to you. Your data may be stored through Wix.com's data storage, databases, and the general Wix.com applications. Wix stores your data on secure servers behind a firewall.

My Wix website tracks data on site traffic, devices used, and referral sources as well as interaction with my Frequently Asked Questions posts.



I do not at present, have an external analytic tracking system activated, such as Google Analytics to track your online movements within my website. I participate in some paid advertising services online, which may have led to you to my site.

I send invoices, and do not collect or store specific bank account information on my site for payments made via bank transfer or credit card. If you choose to pay with your credit card, the payment is recorded and processed through a third party payment processor (Stripe), which has it's own data processing and retention policy. An accounting of your invoices and payments will be kept in a secure cloud program for my required record keeping purposes.

My website and email hosting service providers (Wix and Gmail), payment processor (Stripe or a bank transfer service of your choice), encrypted virtual meeting hosts (Facetime, WhatsApp, Zoom or another) may collect various types of information when you interact with these applications via my site. Please see the service providers' individual websites and security whitepapers to view their privacy practices for more information.

### Why I Collect Such Personal Information

I collect such Non-personal and Personal Information for the following purposes:

- 1. To provide and operate the Services;
- 2. To provide our Users with ongoing user assistance and technical support;
- 3. To be able to contact my Clients with general or personalized notices and messages;
- 4. To process payments;
- 5. To create aggregated statistical data and other aggregated and/or inferred Non-personal Information, which I may use to provide and improve my respective services;
- 6. To comply with any applicable laws and regulations.

### **Information Sharing and Disclosure**

I may disclose personally identifiable information only in response to an emergency covered under the informed consent guidelines, and in response to a legal process, for example, in response to a court order, lawsuit, or a subpoena. I also may disclose such information in response to a law enforcement agency's request, or where we believe it is necessary to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical



safety of any person, violations of our terms of use, to verify or enforce compliance with the policies governing my site and applicable laws or as otherwise required or permitted by law or consistent with legal requirements. Please see the wording in my Informed Consent Document for further information on protective actions for minors, legal obligations, and commitments.

Although I take appropriate measures to safeguard against unauthorized disclosures of information, I cannot assure you that personally identifiable information that I collect will never be disclosed in a manner that is inconsistent with this privacy statement because I do not have control over the security of your internet connection or of external technology servicers' behaviors. I have chosen technology third party partners as carefully as possible with regard for our technology needs and your assurance to security.

#### **Contact Methods**

I may contact you via newsletter by email in addition to phone calls and messaging, I may contact you in writing to enforce any applicable laws such as the right to collect funds owed as part of any agreement between us. I will do my best to always contact you by your preferred method first.

### **Cookies and Other Tracking Tools**

My website and external technology services have the capability to track personal information through the use of cookies. Cookies are small pieces of data stored on a site visitor's browser, usually used for security purposes or to keep track of their movements and actions on a site. You may be asked by my website or your browser to retain or decline cookies.

There are two types of cookies:

**Session (Transient) cookies:** These cookies are erased when you close your browser, and do not collect information from your computer. They typically store information in the form of a session identification that does not personally identify the user.

**Persistent (Permanent or Stored) cookies:** These cookies are stored on your hard drive until they expire (i.e. they are based on a set expiration date) or until you delete them. These cookies are used to collect identifying information about the user, such as Web surfing behavior or user preferences for a specific site.

You can change your privacy preferences regarding the use of cookies and similar technologies through your browser. You may set your browser to accept all cookies, block certain cookies, require your consent before a cookie is placed in your browser, or block all cookies. Blocking all cookies will affect your online experience



and may prevent you from enjoying the full features offered of a site. Please consult the "Help" section of your browser for more information.
